# Report on the Audit of the Financial Statements Qualified Opinion

We have audited the accompanying financial statements of DIS - DYNAMIC INTEGRATED SOLUTIONS S.A. (the Company), which comprise the balance sheet as at 31 December 2019, the statement of income for the year then ended, and notes to the financial statements.

In our opinion, except for the effects of the matter described in the "Basis for Qualified Opinion" section of our report, the accompanying financial statements present fairly, in all material respects, the financial position of DIS - DYNAMIC INTEGRATED SOLUTIONS S.A. as at 31 December 2019 and its financial performance for the year then ended in accordance with the requirements of the L. 4308/2014 as in force.

Basis for Qualified Opinion
As a result of our audit arose that the tax returns of the company for the years 2014 to 2019 have not been examined by the tax authorities as yet. Therefore, the tax results for these years have not been made final. The company has not proceeded to estimation of additional taxes and penalties that may be assessed at a future tax audit for the un-audited tax years and has not made relevant provision in respect of this contingent liability. From our audit reasonable assurance has not been obtained in respect of the estimation of the amount of provision that may be required.
We conducted our audit in accordance with International Standards on Auditing (ISAs) as incorporated into the Greek Legislation. We believe that the audit evidence we have obtained is sufficient
